# Minutes of an Ordinary Meeting held on Thursday 17<sup>th</sup> March 2016

#### 1 Apologies for absence: None

2 Minutes of the meeting held on Thursday 28<sup>th</sup> January 2016: These were read, approved and signed by the Chairman.

**3** Matters arising from the above Minutes: The second of the two Nights Out events in the Community Hall this year entitled Crazy Little Things called Love will be held on Friday 7<sup>th</sup> October.

#### 4 Correspondence:

- Garreg Llwyd Hill Wind Farm a letter giving details of road works on the A483 to facilitate the construction of the Farm
- Teenage Cancer trust Wales a letter giving details of the work of the Trust and requesting a donation. Councillors decided not to donate on this occasion.
- The Clerk read a letter concerning the Fuel Poverty-Nest Scheme. He was asked to post copies of this letter on the notice-boards.

**5 Appointment of new Clerk:** The Clerk reported that he had sent a formal letter to Mrs Gillian Preece offering the post of clerk to her, and that she had sent a written acceptance.

The Chairman welcomed Mrs Preece and expressed the hope that she would hve a long and enjoyable stay as Clerk to the Council. There are many unanswered questions which the Authority will have to address in response to the pressure from the interested bodies. The Community Council has been informed that the consultation period has been extended.
