# Auditor General's report and audit opinion

I certify that I have completed the audit of the Annual Return for the year ended 31 March 2023 of **Llanfihangel Rhydithon Community Council**. My audit has been conducted on behalf of the Auditor General for Wales and in accordance with the requirements of the Public Audit (Wales) Act 2004 (the 2004 Act) and guidance issued by the Auditor General for Wales.

## Audit opinion: Qualified

Except for the matters reported below in my Basis for Qualification, on the basis of my audit, in my opinion no matters have come to my attention to give cause for concern that, in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislative and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

## **Basis of Qualification**

### **Annual Governance Statement**

In my opinion, the Annual Governance Statement is not consistent with the Council's internal controls and governance arrangements for the year:

• Assertion 1: The Accounts and Audit (Wales) Regulations 2014 require the Responsible Finance Officer to certify that the accounts properly present the Council's receipts and payments for the year. The Regulations also require the Council to approve the accounts. Both processes must be completed by 30 June each year.

The RFO has not certified the accounts and the Council did not approve the accounts until 16 December 2021. Therefore, the Council did not make p[roper arrangements for the preparation and approval of accounts.
