## Auditor General's report

### Audit opinion – Qualified

Except for the matters reported below in my Basis for Qualification, on the basis of my review, in my opinion no matters have come to my attention giving cause for concern that in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislation and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

### Basis for Qualification

#### Annual Governance Statement

In my opinion, the Annual Governance Statement is inconsistent with the Council's governance arrangements for the year

- Assertion 4 – exercise of electors' rights. The Council approved the annual return after the commencement date for the exercise of electors' rights additionally no notice was issued regarding the Council and the Responsible Financial Officer certifying the return late. The Council should approve the annual return prior to the commencement of the inspection period and in accordance with statutory deadlines.

### Other matters arising and recommendations

I draw the Council's attention to the following matters and recommendations which do not affect my audit opinion but should be addressed by the body.

#### Misstated prior year comparative figures

The Council's prior year balances in the statement of balances have not been updated to reflect the 2020-21 closing position. The balances stated within the return appear to be the same figures used in the previous annual return i.e the prior year statement of balances show the 2019-20 figures. Lines 9 and 11 figure should match line 7 in this instance.

Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2021-22 was £8.41 per elector.
